17 KJELLBERG: I need help now!

19 911 OPERATOR: What is the address you need help at?

21 KJELLBERG: 1720 7th Street. I got some black guy hitting me.

23 911 OPERATOR: Hold on a second. 1720 7th Street East in St. Paul?

25 KJELLBERG: Yup.

27 911 OPERATOR: What's your name?

29 KJELLBERG: Brian Kjellberg.

31 911 OPERATOR: What's going on? You called about a parking complaint?

32
33 KJELLBERG: Yup. Yup. And he's trying to get his vehicle and I want it towed and he's
34 fighting with me.

36 911 OPERATOR: Okay. He's physically fighting with you?

37
38 KJELLBERG: Yes. Yes.

40 911 OPERATOR: Okay. So, um, so you are, why are you trying to, is, is it his car?

41
42 KJELLBERG: Yes. And I, he's on my property. I told him to stay off my property.

44 911 OPERATOR: Okay. Do you need an ambulance?

46 KJELLBERG: I think he might.
47
48 911 OPERATOR: Did, does, does anybody need an ambulance?

50 KJELLBERG: I have no idea. I would suggest to send somebody soon.

52 911 OPERATOR: Okay. Let me just, hold on a second.

54 KJELLBERG: Like real soon.

56 911 OPERATOR: And he says that it's his car but you're refusing to give it to him?

58 KJELLBERG: (inaudible)

60 911 OPERATOR: I'm just trying to understand.
61
62 KJELLBERG: Yup, well. He's trying to take his vehicle off my property. It's parked
63 illegally.

65 911 OPERATOR: Hold on a second.
66
67 KJELLBERG: He has no right to be on my property.
68
69 911 OPERATOR: Okay. So, I'm just trying to understand. We already have a call in for
70 police so, okay, I'm trying to understand...

72 KJELLBERG: Yup.
73
74 911 OPERATOR. How is his car on your property and why won't you let him have it? I
75 guess I'm just trying to...

77 KJELLBERG: Cause I want the police, I want the police to, I don't know why it's on my
78 property. He probably parked there. Um, I want him off my property and
79 I want his vehicle towed cause this happens all the time.

81 911 OPERATOR: Okay.
82
83 KJELLBERG: He has no right to be on my property. I asked him multiple times to get
84 off my property and he kept on coming and he attacked me. And I want to
85 press charges.

87 911 OPERATOR: Okay. What race is he?

89 KJELLBERG: Black.

91 911 OPERATOR: How old is he?

93 KJELLBERG: He also called...uh, maybe 30.

95 911 OPERATOR: How tall?
96
97 KJELLBERG: 5'7" maybe.

99 911 OPERATOR: Thin, average, heavy?

101 KJELLBERG: Thin.

103 911 OPERATOR: What kind of shirt, what color shirt is he wearing?

105 KJELLBERG: I don't know, he ran away.

107 911 OPERATOR: Where did he go?

109 KJELLBERG: Uh, two doors down.

111 911 OPERATOR: Into a place or just on the street still?
112
113 KJELLBERG: Uh, into a house.

115 911 OPERATOR: Um, two doors down on the same side as you or which way from you?
116 East? West? Do you know what house?

118 KJELLBERG: Uh, to the east, to the east.

120 911 OPERATOR: Did you see any weapons?
121
122 KJELLBERG: No. But he hit me about four times in the face.

124 911 OPERATOR: Okay. We have police coming, okay? Um...

128 911 OPERATOR: ...you know, don't engage with him if he comes back.

130 KJELLBERG: Nope. I'm not going to. I told, I asked him quietly to get off my property.
131 Um, he came up and just started beating on me.

135 KJELLBERG: Um, I have, oh, now he's coming back. With somebody else.

137 911 OPERATOR: With one other person?

139 KJELLBERG: Yup. I'm just...

141 911 OPERATOR: Can you go inside?

143 KJELLBERG: ...I'm just inside the door. Yup, I'm inside now.

145 911 OPERATOR: Okay.

147 KJELLBERG: I, I shouldn't have to be inside my own house just to (sighs)...

149 911 OPERATOR: Did you lock the doors?

151 KJELLBERG: Yup.

153 911 OPERATOR: Okay.

155 KJELLBERG: But.

157 911 OPERATOR: Okay.

159 KJELLBERG: But whoever, I have a few, I, they took the plate down last time. Whoever
160 it is, I want to file charges.

162 911 OPERATOR: Are you in a business or your home?
163
164 KJELLBERG: It's my home.

166 911 OPERATOR: At 1720 7th Street East?
167
168 KJELLBERG: Yup. It's an old fire station.

170 911 OPERATOR: Okay. I just want to make sure. Hold on.

172 KJELLBERG: Yup.
173
174 911 OPERATOR: I'll stay on the line with you until they get there.
175
176 KJELLBERG: Thank you. I've had issues with the neighbors and both the neighbors for
177 the last couple years.

179 911 OPERATOR: Okay.

181 KJELLBERG: I've called multiple times for people parking in my driveway.

183 911 OPERATOR: And you're at 1-7-2-0 7th Street East in...

185 KJELLBERG: Yup.

187 911 OPERATOR: ...so on the corner of 7th and Flandrau?

189 KJELLBERG: Yes, ma'am.

191 911 OPERATOR: Okay. And you're Brian.

193 KJELLBERG: Yes.

195 911 OPERATOR: Okay. Okay. Alright. If anything changes, I want you to give us a call
196 back. Okay? They, we do have police on the way. Okay.

198 KJELLBERG: Can they call, can they call when they get here?

200 911 OPERATOR: Um, yeah, or so they'll either call or...

202 KJELLBERG: I can just watch out the window.

204 911 OPERATOR: Yeah, or, and then, or we'll call and have you open the door. So, if it
205 comes from a private...

209 911 OPERATOR: ...or blocked number, I need you to answer that, okay?

211 KJELLBERG: Yup. No problem. Okay.
