
Statement by Officer L.Hanks #2989 on 5-16-2004 @1600 hours

I was working marked squad 430 with Officer Becker. We assisted on a robbery of business at 3300 Lyndale Ave N. We arrived and were informed by Sgt.Kjos, squad 406 that it was a homicide. Officer Becker and I were asked to canvass the neighborhood.

I went from 3300 Lyndale, the even side and proceeded to 34th Ave N.

3310 Lyndale Ave N, Etta McCabe was the original caller. She did not see the suspect.

At 3312 Lyndale I spoke to 2 17 year old males who answered the door. Elijah Joseph James [REDACTED] 87 and Andre Lamont Atlas [REDACTED] 87. Both said they did not see or hear anything.

3316 Lyndale resident arrived home around noon, said the police were already on scene at 3300 Lyndale.

3322 Lyndale no answer at the door.

3330 Lyndale no answer at the door.

3334 Lyndale, resident saw nothing.

3338 #1 Lyndale, resident just arrived home, saw nothing. #2 no answer at door.

33[REDACTED] Lyndale talked to resident, Michelle Amos and her two sons, Joseph William Amos, [REDACTED] 88, Marshall LeAnthony Amos, [REDACTED] 89. Home phone there is [REDACTED]. Michelle Amos told me she was at the flower shop with the female victim prior to police getting there. While at the address I talked to Rapheal Jones [REDACTED] 85. He told me he lives at 33[REDACTED] 6th St N, upstairs. Rapheal was 6'0 heavy build with a dark skin. He had a short hair cut.

The residents of 3346 and 3350 Lyndale both said they did not see anything.

I then walked westbound on 34th to 6th St N and began walking southbound on 6th Street, knocking on the doors on the odd side of the street.

3349 6th St, no answer at the door.

3345 6th St, no answer at the door.

33[REDACTED] 6th St N up/down duplex. 1st floor Willie Wilson, ph [REDACTED] black male, in his fifties, has a white female and a white male as roommates. Wilson said he and his roommates were sitting at the kitchen table around noon. The table faces the back driveway and alley behind the house. They did not see anyone or anything out of the ordinary.

The upstairs resident at 33[REDACTED] 6th St N is Sharon Denice Neal [REDACTED] 66. She has four children, two daughters and two sons. The sons are Rapheal Jones [REDACTED] 85 and David Neal [REDACTED] 88. Sharon's mother, Olivia also lives there. Sharon said she was asleep prior to me getting there, Olivia said she did not see anything. David Neal was not home at the time I talked to Sharon.

3339 6th , male resident said he saw nothing.

3335 6th , female resident was asleep, did not see or hear anything.

3331 6th, no answer at the door.

3325 6th , resident saw nothing.

3323 6th , no answer at the door.

3319 6th , no answer at the door.

3315 6th , unoccupied.

3309 6th mother of resident was sitting on front porch did not see or hear anything.
3309/3311 6th side by side duplex, 3311 no answer at the door.

3307 6th , no answer at the door.

We covered the 3343 6th st until relieved by Sgt Kjos.
