On 5/19/04 at approximately 0800 hours SGT KEEFE contacted TODD BARNETTE of the Hennepin County Attorney's Office and requested a review of MARVIN HAYNES juvenile records to see if any of HAYNES recent domestic assault cases could be charged. BARNETTE called back about an hour later and stated that HAYNES failed to appear for a recent court appearance. Consequently BARNETTE issued a bench warrant charging HAYNES with failure to appear. After the warrant was issued, SGT KEEFE contacted the MPD Organized Crime Unit and requested HAYNES be picked up for this outstanding warrant. HAYNES was located and booked for the warrant on 5/19/04 at approximately 1240 hours.

On 5/19/04 at 1410 hours SGT KEEFE and MATTSON met with witness MCDERMID at her residence to show her another 6 person photo spread which included MARVIN JUNIOR HAYNES, DOB 12/6/87 and DAVID EUGENE NEAL, DOB [88] who was a subject we still wanted to eliminate or confirm. This lineup was done with booking photos which included a front and side view. The identifying information was folded over so that no name or other information was visible. Witness MCDERMID looked at each photo and ruled out those persons including ruling out DAVID NEAL. When she got to photo #5 which was MARVIN JUNIOR HAYNES MCDERMID gasped, placed her right index finger on his photo and said, "Oh my God that's him". She further stated that from this photo that she was viewing the suspect is wearing his hair longer than shown in this photo. She was then shown the remaining photograph so that she saw the entire lineup but she came back and identified number 5. MCDERMID then gave a taped statement immediately after the lineup was shown in which she identified MARVIN HAYNES as the person who had come in to rob her on 5/16/04.

Upon our return to the officer investigators sent SGT KING and WEHR to meet with witness B to show witness B a photo spread. SGTS KING and WEHR prepared a lineup which included the same individuals that KEEFE and MATTSON had shown in there lineup so that Witness B was looking at a fresh unmarked lineup. According to SGTS KING and WEHR, witness B also identified the booking photo of MARVIN HAYNES. (See supplement #23).

At approximately 1800 hours on 5/19/04 SGTS FOLKENS and WAGNER brought MARVIN HAYNES to the Homicide Office from the JDC. SGTS KEEFE and MATTSON entered the interview room to speak with him at approximately 1810 hours. He identified himself verbally as MARVIN JUNIOR HAYNES, DOB 12/6/87 and stated that he lives at 3343 Russell Avenue North. He stated his nickname was LITTLE MARVIN. SGT KEEFE read HAYNES his Miranda Warnings at about 1814 hours. After each portion of the Miranda Rights were given to HAYNES he was asked to explain what it meant to him and he explained in his own words exactly what the Miranda Warnings meant. HAYNES waived his Miranda Rights and agreed to talk to investigators. Per Scales this conversation was recorded, video and audio.

Investigators asked HAYNES who he would have been with over the weekend. HAYNES stated that he was with POOPY (later identified as ISIAH HARPER) on Saturday at MUFFY's house. When he was asked where he would have been on Sunday the 16th (the day of the homicide) he stated that he got home about 2 a.m. Sunday morning and that he then slept until 3 p.m. HAYNES stated that his mom and/or sisters would be able to verify that. HAYNES stated that he left at about 3 p.m. When investigators had first seen MARVIN HAYNES on the 19th half of his hair had been in braids. HAYNES was asked when his hair got braided and he stated that DEDE had braided his hair Sunday evening sometime. HAYNES was asked if he owned or handled guns and he stated that he had been caught with a b-b gun at one time but otherwise does not own or possess any and has never handled any guns.

HAYNES was asked if he knew about the flower shop robbery and he stated that he was not aware of any flower shop robbery stating he had never watched the news to see it and no one told him about the flower shop robbery. SGT MATTSON showed him a photograph of the flower shop from the newspaper with all of their information covered up and he still stated that he did not know about this place and in fact stated that he has never been in this flower shop. In short HAYNES denied all knowledge of this flower shop and stated that he had never been

in it and did not commit this robbery/murder.

SGT MATTSON left the homicide office at approximately 1925 hours to go sign a Search Warrant for HAYNES residence at 3343 Russell Avenue North. HAYNES remained at the office with other investigators.
