These recordings were taken by an anonymous source inside of Patriot Front during August to December 2021. Unicorn Riot has produced transcript PDFs, MP3s and videos from this set of recordings. The transcripts and the Mp3s use the same set of timecodes. The main report on our website uses separate timecodes that match our videos, which are lightly edited to remove silence, with an additional introduction and credits.

The .mp3 files (as opposed to slightly shortened videos) represent the uncut documentation of these Patriot Front voice meetings. These uncut audio files have been altered as little as possible in the interests of source protection.

Accuracy of transcripts and speaker identities

Unicorn Riot has done our best to compile transcripts with the most accurate time stamps and speaker identifications possible. Due to the combination of machine transcription and extensive human labor, there may be occasional errors in speaker IDs indicated in transcripts. but we are confident that the vast majority of the speaker IDs and content are correct. Some transcript timestamps are incorrect due to unavoidable issues with using machine transcription at scale, however, the majority are accurate.

Please note that these recordings may include Patriot Front members whose voices were not identified by us. When we were unsure about a speaker's identity we have left that line in the transcript without an assigned name, which machine transcription services usually tag as 'Unknown'. Many Patriot Front members have been identified by researchers, activists and journalists by linking multiple pieces of evidence to online personas.

They don't need me to host Mumble meetings, they don't need me to type, [inaudible] to wrangle the Oregon guys, it sounds like he might take the initiative and do that job. And as for over in north Idaho, Johnny might be doing it, he seems really avid in planning things and has a good head on his shoulders [inaudible] up to doing that, but who knows, there might be a new, a new guy that comes in his region that totally blows him out of the water and is totally more Network Director material than he is, you never know. But as of right now we need someone over there to fucking start picking up the pace, lighting a fire under people and getting stuff going. Alright, so without further ado, let's start this Mumble meeting. Um, so I want all you guys to look at the Network 8 chat. I posted our activities spreadsheet, I want you all to go look at it and give it a flag react because I spent a lot of time making that stupid thing because I'm boomer tech, so give it some love. And, yeah, just look at that for a minute. What we did. Beautiful. To me it felt like we honestly haven't done a whole lot in these past couple weeks but then I made that and I was like, actually that's good. It shows that almost every guy on there is really pulling his weight and it's, it's good, that's the type of activity I'm looking for, if we continue to do activity like that we are going to see really good growth. Moving forward, we have about four banners, those need to be dispersed around, how do you guys think that we should use those

banners? I think we should all actually, you know what, I'll just let you guys discuss amongst yourselves, how do you think we should use those banners? Where should we put them?

Okay.

[Inaudible] would seem best to me. Like maybe on junctions, kind of where I-5 and I-405 meet, or where I-5 and, crap what's it called, down here in Olympia, it turns into, 509, I think it is, there's just a lot more traffic.

You know you have, what, 101 and 8 or something like that?

Yes, there is a roll cage up in Bellingham. I call it roll cages but, um it is a footpath that goes over, I think I-5, yes. And it is a complete chain link fence that goes all around, has a ceiling, over the walkway. I've seen guys do banner drops on those and they're really stinking hard to remove. Because you have to climb on top of the chain link to go get it down. So those tend to stay up a lot longer than one you just put up next the freeway and someone can pull up and pull it down real quick and drive off. So when it comes to planning banners, the key is to put them in an area that is hard to access. No amount of bike locks and padlocks and metal zip ties and grommets and stuff is going to prevent people from getting those banners down because they'll just call the city and the Washington State Department of Transportation will come tear it down. So we need to focus on putting them in locations that like, WSDOT isn't going to care about or it's just simply really hard to get. So overpasses that have a big fence. We can put it up against on the fence and leave it there, are good. And then, Jack, I want you to write all these ideas down. Take notes for the meeting.

Jack WA (Matthew Clement) 13:22

I'm currently doing that, it's fine.

ND - John WA (Colton Brown) 13:25

Beautiful, good work. Then, other places to put banners, I did think of, what if we put like a banner on the side of a cliff. Like you know, there's a lots of cliff faces that have like paint on them and stuff, facing

freeways that go out of the, out of the state and stuff. I was thinking what if we suspended a banner from one of those and we use like concrete stakes and rope to like hold it up. That's an idea. Or putting it from some of the big abandoned buildings that face the freeway around Seattle, Tacoma, other places like that. I've seen places that, that might be doable, gonna have to probably get like a tall extension ladder that like pulls out, like folds up into a small little ladder to hold, we can get one of those expensive, nice extendable ladders. And we could use those not only for those buildings, but also billboard cover ups, if we ever find a nice billboard that needs to be covered up. But there's one particular building off the side of the freeway exiting Seattle to go back down south on the right. It's got graffiti on the top of it. I really want to get up there and I really want to cover up that graffiti with some big banner stencils. I think it'd be doable. Um, another idea. Vicious. Another idea I've been looking at is coming into Seattle towards your right there is a side of a concrete wall with a nice grassy like platform to operate on on the side of the road and there's tons of graffiti on it. It'd be really easy for us to do it at night and not get caught, get the big stencil up and thousands upon thousands of people will see it the next day and it possibly will stay up for a long time until someone actually goes and cleans it up because we'll be using such big banner stencils, right.

Are you talking about the convention center?

Jack WA (Matthew Clement) 15:38

Yeah, which direction, when you say it's on your right, are facing are you coming north, south, east or west?

ND - John WA (Colton Brown) 15:43

Yeah, it's like, it's in Seattle, like I don't know if it's coming right into Seattle, but it's definitely like, in the main artery if you just were to drive straight up to Bellingham, we just go straight through I-5 I think, and stay on I-5, it's on the right. I don't know, I've been trying to look around on Google Maps/Google Earth, that, that program is a little outdated, so, you know, it's probably not showing current spray paint and that's probably why I can't find it. But when we do the stencils, if you guys have all read the guides, I know you guys have all read the guides right? So, you better, though, there's in the stencil guide, we need to only put up our stencils over where there's already graffiti so we can argue that there's plausible deniability if we ever do get in trouble and the court case will get dropped. But um, but we just don't get caught. We're quick about it, we're efficient, professional, [inaudible].

Professional tagging.

ND - John WA (Colton Brown) 16:36

Yes, professional tagging, it does look professional too, you know, this, the swath of disgusting graffiti, you have a whited-out area with our nice orderly stencils and it just kind of highlights what we do and what our purpose is in this world, is to create order, compared to all that other degenerate filth that's all over the wall. So those are some ideas. I also would like to see some more stuff done in Snohomish County. Do you guys remember, during those BLM riots, Snohomish County, they had people that were boarding up their businesses. They were standing outside of them with AR-15s, open carrying rifles,

they had barricades all up and down the streets. So I think, you know, we might have some sympathetic people out there that are, they're sick of the way things are right now, and there's some people in that crowd that are somewhat redpilled you know, they're on board with what we believe. So I want to definitely start doing more activism there. So when our posters come in, we're gonna probably hit Snohomish County kind of hard.

I suppose you're right, John, when you're talking about ideas for the banners, we've got four banners. You don't want to put them on overpasses anymore. You want to put them on cliffs and abandoned buildings?

ND - John WA (Colton Brown) 18:02

We can, because it, because it, ultimately more people are going to see online than they do in person. I'm just saying that there's areas that are simply better for putting them on but if we want to just put them on a regular overpass like during rush hour traffic when traffic is backed up to the moon and tons of people will see it, that's fine, it's still, still a bunch of people are going to see it, it's going to be effective and especially because it's during rush hour traffic, you know, Washington State Department of Transportation is going to be busy, they're gonna be stuck in traffic, they're gonna take a while to get it, a bunch of people will see it...

Jack WA (Matthew Clement) 18:36

Yeah, I like that bridge that we hung it over...

ND - John WA (Colton Brown) 18:39

...like after work.

Jack WA (Matthew Clement) 18:40

...a long time ago in Olympia. There's the one that overlooks I-5, it's the one with extra high fencing, you know what I'm talking about, extra high fencing very high up above the freeway [inaudible].

ND - John WA (Colton Brown) 18:53

The big arc, big arch? Yeah, I want to do, I want to finish our stencil sets so we have the complete alphabet with the giant letters and do another one of those ones like we did over the portal, that says Reclaim America, patriotfront dot us all in the big three foot letters and it'll be two banners glued together. Out of the suburban area of Seattle to go down in rural areas and fish and all that when there's lots of heavy traffic on like a Friday night or maybe on a Sunday when they're all coming back in. That'd be good. We could also do one over I-90 over in Kittitas. We did that on a Sunday, back in, that'd be good. But, just did stuff there. I gotta still finish, I just now got my, my SD card reader so we can take all the photos and video from the nice camera that Vincent has and I'm internally uploading it all right now.

So I-5, I-90, [inaudible] a little bit ago, was it Ethan, you had a suggestion?

Ethan WA (Justin O'Leary) 20:24

You said did I have a suggestion?

Jack WA (Matthew Clement) 20:26

Yeah, for where to drop a banner, are we talking about I-90, I-5, I thought you said something a couple minutes ago, maybe not.

Ethan WA (Justin O'Leary) 20:32

I was just saying interstates in general, because obviously you want to hit high traffic and yet preferably somewhere where it'll stay up for a minute and I think, like you guys were saying, when you come in I-90 westbound, like I think you guys have hit that, right before you go in the old tunnel before you hit Seattle, that's like a good spot.

Jack WA (Matthew Clement) 21:00

I almost want to get a couple of spots that are, I don't want, that are out of Seattle away, like in Lewis county here there's a couple of interstate, or a couple of overpasses, that do have those bars we could put zip ties on, they're not just like the freeway median, I almost want to hang it there, see how long it would last in the middle of nowhere. Well, it's not in the middle of nowhere but on an overpass that's not near a busy city. Going [inaudible].

ND - John WA (Colton Brown) 21:27

We did, the one we did in Vancouver stayed up for a week, remember, that one I had you plan forever ago.

Jack WA (Matthew Clement) 21:34

Nice, yeah, we can do that one again, that exact same spot.

ND - John WA (Colton Brown) 21:39

Sure. So what do you guys think, should we make a day of doing all four of these banners at once, do you think we should split up in a, in a couple few different groups of threes and put them up in different areas, should we, all of us together, go and put them up in different areas to look like we have more guys in the action report? How do you think we should go about doing it?

I like that idea. But it'd be nice to get some some distance on these two, so if we're thinking about doing Bellingham and then Vancouver that's going to be a good amount of time.

Well, the idea would be instead of all of us go do one, it'd be like four banners, same time, crews of two or three, or crews of two, because we've got eight guys, eight guys four banners. If each of us pair up we could drop one, but I know that the distance isn't quite equal, for guys to.

Well if we look at the map we got, so we got guys down south, Olympia, Centralia we got [inaudible] area and stuff. Don't have anyone in Tacoma or Lakewood or Parkland, or between really Seattle and Olympia, so we might want to do some stuff in Tacoma. We haven't hit Tacoma in a while.

I feel the same way about Lakewood. I'm happy to have a guy in Olympia. Nice. Glad you're here with us Clarke, very cool.

Sorry I dropped connection or something. Um, what about another mural cover-up?

You know where Costco in Seattle is?

Oh there is also a Black Lives Matter mural somewhere in downtown Seattle that Tyler mentioned that was on, like, the African Heritage Museum or something? Get [inaudible] some guys [inaudible] different mural out of it, you know?

Hey, I got a question for you guys. So, so a lot of places in northern Idaho don't necessarily have any stencils already. Like a lot of people don't do graffiti up here, or it's at least, it's really handled well by the cities. So what was your, what would be your recommendation for PF stenciling in this area? Because I've been told like, hey, unless someone hasn't, unless someone has done stenciling there before, don't do it.

ND - John WA (Colton Brown) 29:47

Yeah. Have you read the stenciling guide?

Johnny ID 29:49

Well, yeah.

ND - John WA (Colton Brown) 29:51

So don't, don't stencil something that doesn't already have artwork or graffiti on it, but the only artwork we cover up is anti-American artwork and that's when it's extensively planned with the help of said network director or Thomas. But yeah, don't just graffiti anywhere. No, the world's already ugly enough as it is we don't want to help contribute, though just, and for legality reasons, you can argue plausible deniability in your case. Let's say you get in trouble, you get caught putting up a stencil on the side of an underpass but there's already graffiti there, you can argue that the state never cared in the first place though and then you can beat the case. That's for people's safety, why we have that [inaudible]. Because we've had a lot of guys that went and they just grabbed the spray paint and they went crazy and they kept getting in trouble because they didn't know what they were doing, so, that's why we follow the guides and we plan stuff, you wear a mask, hide your face, no face no case, leave your car parked a long ways away, scout the spot out beforehand and already have been well practiced with using stencils in the first place.

Jack WA (Matthew Clement) 31:10

What was the question? Maybe I missed it.

ND - John WA (Colton Brown) 31:21

That answer your question?

Johnny ID 31:23

I mean, so in essence we don't stencil up here, that's what I'm getting.

ND - John WA (Colton Brown) 31:30

Spokane is a good spot to stencil. [Inaudible] probably ask Thomas a little bit more, like if there's some abandoned place you could probably stencil it and stuff, but otherwise I wouldn't go out of your way to just start vandalizing underpasses. So next weekend, the weather, fellas, see what the weather's like. I think we're in soon for another fitness day and throwing up some banners. Looks like it's gonna be pouring next weekend so I don't wanna do fitness in the rain. We can, let's go do those banners. Did we agree on where we're going to deploy those? We should do one here, one there.

Jack WA (Matthew Clement) 32:41

Where's here and there? We're all in different places.

ND - John WA (Colton Brown) 32:45

Everett really liked it when we did that last one. They complained and they tried to do a manhunt. I think somewhere in Seattle would be good.

I'll leave you guys to your planning, I'm going to go up to #general.
