

# 2021-11-24 Casual Mumble with Lawrence FL, Matt MN

These recordings were taken by an anonymous source inside of Patriot Front during August to December 2021. Unicorn Riot has produced transcript PDFs, MP3s and videos from this set of recordings. The transcripts and the Mp3s use the same set of timecodes. The main report on our website uses separate timecodes that match our videos, which are lightly edited to remove silence, with an additional introduction and credits.

The .mp3 files (as opposed to slightly shortened videos) represent the uncut documentation of these Patriot Front voice meetings. These uncut audio files have been altered as little as possible in the interests of source protection.

## **Accuracy of transcripts and speaker identities**

Unicorn Riot has done our best to compile transcripts with the most accurate time stamps and speaker identifications possible. Due to the combination of machine transcription and extensive human labor, there may be occasional errors in speaker IDs indicated in transcripts. but we are confident that the vast majority of the speaker IDs and content are correct. Some transcript timestamps are incorrect due to unavoidable issues with using machine transcription at scale, however, the majority are accurate.

Please note that these recordings may include Patriot Front members whose voices were not identified by us. When we were unsure about a speaker's identity we have left that line in the transcript without an assigned name, which machine transcription services usually tag as 'Unknown'. Many Patriot Front members have been identified by researchers, activists and journalists by linking multiple pieces of evidence to online personas.

But once I have the curtains in, honestly, I, oh and I get like, you know, drawers and things like that I should be pretty much good.

Wait, are you converting your car....

Into a house, yeah.

**Matthew MN 00:32**

That's pretty slick.

**ND - Lawrence FL 00:34**

Yeah, I've got the back, the table made. I've got, it's made out of PVC pipes and a piece of plywood. I've got, it's also got a cargo net underneath the frame so that way I have two [inaudible] things. I've got a one burner, you know, grill. Using butane or propane. Some cooking utensils...

Hey, what's up Vincent.

**ND - Lawrence FL 01:00**

Got a cooler. So basically, if I wanted to just kind of live out this car, I could and it would be pretty slick.

You know, you could actually, basically become a legal nomad in South Dakota. I think if you spent one day at a hotel in South Dakota, and you can get like a P.O box or something, you basically like live in your car traveling the country.

I'll consider that option. I'll keep it in mind yeah, just go make...

Sexuality is not real. Being gay, being straight, all that. It's fucking not real. It's fake. They're not born that way. No one's born that way. It's just, it went from being like, just an action, okay? And was turned into like, an identity and all this other bullshit in recent times. What do you think of that?

**Matthew MN** 02:56

Shit. What's up Vincent?

Hey! I can, I can dig that, but I feel like, I've seen so many memes that are like, "Return to monke."

Where it's like you abandoned consciousness as a, as an ideal, that it sort of sounds like that. See, like you, I like to think that, you know, we're separate from from the animals.

And that, that we have certain layers of abstraction, layers of consciousness above that.

Because if we do know that they aren't born that way, and that they're more or less, you know, there's no gene that says, oh, this person's a heterosexual, this person's a homosexual, you know? But I think the mere creation of this binary, you know, but oh, you know, because, like, what's heterosexual mean? It just means normal. You know, just means you're not like, a sodomite.

**Matthew MN** 04:29

Yeah.

**ND - Lawrence FL** 04:29

They came up with this thing. Like Freud or whatever. Freud, you know, he came up with this idea, like, oh, this, this and this, that and it's like, well, now people who, you know, now they adopt, not only is it like their vice, okay? Just as it is, a vice. Now it's a personality now. It's a lifestyle now. It's "Oh, I was born this way," you know. And it's this whole big convoluted mess and they built an entire life around the fact that they get their asshole blown out. Like, it's ridiculous. Anyway, I'll send it to you. I don't think gays are real. I don't think straight people are real. They're just people, and they're just actions and consequences.

Some choose to do very degenerate actions.

**ND - Lawrence FL 05:21**

Yeah, some choose to do degenerate actions. But that's just what, that's what they are. It's just, it starts, it stops there. You want to stop being a degenerate? Okay, then just fuckin' stop.

You sound like a bigot Lawrence.

**ND - Lawrence FL 05:38**

You're damn right.

**Matthew MN 05:42**

Are you some kind of evil white supremacist neon nazi?

**ND - Lawrence FL 05:48**

Most likely.

**Matthew MN 05:55**

Oh, Lawrence, I don't know if you saw the white pill about the whole C-ville thing too but you know the amount of damages they assigned to the individuals...

**ND - Lawrence FL 06:05**

What, which individuals?

**Matthew MN 06:08**

Basically everybody but Spencer, Cantwell, Kessler and Fields, some of the legal fags in some of the Threema groups for the TRS stuff, like the lawfags are like, there's like, some Supreme Court precedents where the damages assigned are like, basically illegal. Because I think, there's like some legal [inaudible] with it. But, it's like, quantified damages or something like that. It's like, they, the jurors either said zero or one dollars because there's like no real damage. I think the cap was like seven times like, like what, seven, seven or nine times like whatever that is. So I think, like, the worst somebody's on the hook for is like \$7 or \$70, I don't know, I'll have to find the explanation of it. It's like some Grade A [inaudible], but it's interesting.

I thought I saw, I didn't actually click on it and read it, but I heard something about C-ville people alleged, like being charged for like \$15 million worth of damages or something.

**Matthew MN** 07:13

Oh, yeah, they're not gonna get that, most, half of that is basically Alex Fields who is like, fucked anyways.

**ND - Lawrence FL** 07:24

Got it.

**Matthew MN** 07:29

Yeah, these Jews spent like \$15 million, and they're not going to get a dime. That's the funny part.

**ND - Lawrence FL** 07:38

Based.

**Matthew MN** 07:39

Like, they ain't gettin' shit, like, you know, these fucking kikes funded by the ADL are gonna like just get their headline and that's about it.

Yeah, I don't understand how this works, like, like nobody has that much money.

I imagined within that group, like, how do they, how are they planning on getting it?

Is it just going to be wage garnishments where it's going to be you know, like \$100 a month.

Yeah, that's what they're gonna do, actually, I think the legal cap basically is like, well, people like Cantwell are fuckin' broke. I think Spencer's fuckin broke. Kessler, apparently that guy like, lives with his dad. So I think he's broke too. Like, you know, they are, even if they're making minimum wage, like it's only like \$120 a month is what I think somebody calculated.

Hm.

**Matthew MN** 08:40

But even then, like, a lot of the guys aren't even on the hook for that much. Odds are it's going to be appealed. But it's going to be interesting to see what happens, but I don't know, like, some people actually say, like, despite what these fuckin like Jewish journalists are putting in the headlines, it's actually a big [inaudible] for the plaintiffs.

Yeah. Oh, well, best of luck to all of them I guess. I mean, for all the criticism we could probably offer, to an extent if they hadn't of gone out and done what they did, we wouldn't be here having this conversation doing something better right now, you know?

Well, yeah, it's, people needed to learn the lessons the hard way for us to basically adapt and overcome, right? Like half of the stuff that was used as like evidence in this quote, "conspiracy" was like basically like, fedposting and shitposts on Discord, right? You know, like, people making jokes about like, beating up communists and shit like that.

Yep.

**Matthew MN 09:52**

Like, you know, the, these, these Jews, there's no such thing as a joke to them. Right? Like they even brought like, I think, uh, this one quote "Holocaust expert," you know, basically complained about the Holocaust. And then they basically stated there's no such thing as an innocent racist joke. Like, kind of like racist jokes are equal to violence to these kikes.

Wow. Oh, oh, well, I mean, that's how they work, doesn't matter how retarded it sounds. I mean, they'll twist the law against you, however they're able.

Oh yeah, no, the absolute chutzpah of these kikes. And that judge too, is bought and paid for by the ADL. He literally has like antifa on his, like, literal antifa law clerks that the, one of the plaintiffs sent money to over Venmo and they said it was for like, lunch or something like that, which, you know, it's just retarded, like she's, she's paying off the clerk's basically. And the judge is also apparently handling a suit against Alex Jones. So they, they basically went judge shopping because the judge will do whatever these Jews want them to. I think the words that Striker used to describe him was a neoliberal mercenary.

I mean, pretty much sums it up. Like, I wish I could say I came up with that, but I'm not, I'm not very good with words like that.

So are lawyers, completely unrelated, I'm unsure, like I know, like real estate agents, their information is public. Like, because they're public servants, they have to have their name, their address, publi,c

publicly, you know, a business name, you can put a PO box. But still, you know, is it same with lawyers? Um, that's a good question. I don't, I don't think it is. If it would, wouldn't it probably only be like the prosecuting attorneys or whatever, like the district attorneys.

Yeah, I mean, though, some will make like, their, their office address and whatnot, like very public, just because they want customers.

I don't think the bar actually publishes like, lists of who's certified and all their information.

**ND - Lawrence FL** 12:22

Interesting. Just wondering, in case if I, well, I am going to go through with [inaudible] full through with that. So there you go. Anyway.

Oh, we definitely need a, the whole real estate thing, or the law thing?

**ND - Lawrence FL** 12:47

The law thing, the real estate, I basically, I, more or less like gave up on, but I've got 20 something days still technically to finish it. But even though I'm not really seriously doing it, I'm just kind of like, skipping through it and just answering the questions at the end of the test, getting them wrong and then just redoing the test over again immediately and getting 100 percent, because that's what John Colorado told me to do. And said you're never going to use it anyway.

But I don't, I don't understand like, why real estate people need to have their names in the public record.

I don't understand why, I think it's because they're supposed to be like, public servants or something. But yeah.

Yeah, I do the, I try to do whatever I can to basically minimize information out on me about the internet. Like there's still some stuff out there, but I don't think it's really that actionable.

Yeah. If I didn't do the real estate thing all the way I would just get a legal business name and just have it be something, not Lawrence or whatever.

**Matthew MN** 13:59

Well, yeah, get a Delaware LLC or whatever and get a registered agent or like register in Wyoming and just have a Registered Agent.

**ND - Lawrence FL** 14:10

Yeah.

**Matthew MN** 14:10

That's what Scott did to keep his information out of public record.

**ND - Lawrence FL** 14:17

Okay. I'll keep that in mind. I'll probably even ask him about how to set that up too.

**Matthew MN** 14:23

Oh, yeah, Scott will tell you.

**ND - Lawrence FL** 14:27

Has anyone talked to him recently?

**Matthew MN** 14:30

Are you asking or did you?

**ND - Lawrence FL** 14:33

Yeah, I mean, I talked to him like, a month or so ago, I think? But what about you?

**Matthew MN** 14:40

Yeah, it's been a while. But you know, last I heard, he's, he's, he's been pretty busy. But I heard he's trying to get out of, get, basically find a new place to move to.

**ND - Lawrence FL** 14:56

Yeah, that's awesome. That's awesome. That sounds like what he told me too, more or less. Oh well, hope he figures it out.

**Matthew MN** 15:09

Yep, I do miss the guy. I liked talking with him on Mumble. There was never a boring day when Scott was on Mumble.

**ND - Lawrence FL** 15:20

Yeah, liked Scott [inaudible] some stupid shit like with the Euro trip and the, you know, whatever else. Like I also heard that like, I mean some people describe them as like, you know, a grifter who was like

making things to profit off like white nationalist communities or, you know, later on the metal community, from teenagers and whatnot on there, which is kind of true.

**Matthew MN** 15:46

Oh, he's a capitalist, Lawrence. Like, he doesn't apologize for it.

**ND - Lawrence FL** 15:53

True, doesn't necessarily excuse it, but you know...

**Matthew MN** 15:59

I don't know if grifter is the right way to put it.

**ND - Lawrence FL** 16:03

Maybe, that's, these are other people's words, not mine. But there's nothing wrong with like, you know, going to community and doing things tailoring it to the you know, to that to their liking, which is what he did, is perfectly acceptable. But yeah. Although he didn't really understand the community as well as he could have if he'd listened to me more, you know, but anyway. Because the patch scene in the metal community is different from that of like, the 4chan /K/ scene, you know? You wouldn't think [inaudible] it would be more complicated, but it can be, you know, for just patches.

**Matthew MN** 16:54

I mean, yeah, some of those, like, patches are like really impressive. It's, it's astonishing, like, how detailed some of them are.

**ND - Lawrence FL** 17:07

Yeah, I've seen some crazy ones. It's ironic actually, I'm more inclined towards the really cheap canvas screen printing patches now than I ever have been. I think it's because like, well, it's a style change because it's just like, you know, it comes with like, the music and whatnot I listen to now, but also because like, it's a kind of practicality element to it. Because when you cover your jacket or your article of clothing in a ton of patches, it becomes very, very stiff. If they're like, all embroidered patches or woven, but if they're silk, if they're like, a canvas with like, you know, screenprint on it, like, super cheap like, \$2 patches, you know, it's like, that stuff's soft, it can bend with your body, you know. Just slap it on and it's good to stay.

**Matthew MN** 18:00

Yeah, I don't really collect patches. I've just been buying CDs lately. Though I did, I did manage to cop some of those records, but I don't have a fucking record player.

**ND - Lawrence FL** 18:14

What band? What band?

**Matthew MN** 18:19

Oh, Black Magic SS.

**ND - Lawrence FL 18:23**

Which, which records did you get?

**Matthew MN 18:25**

They were all sold out except for Rainbow Nights.

**ND - Lawrence FL 18:29**

That's a good one. George Washington, he's got a record player. Or George Minnesota I guess now.

**Matthew MN 18:35**

Yeah, we stole, we stole George Washington.

**ND - Lawrence FL 18:40**

Yeah, you did. Go over to his place some time and put it on.

**Matthew MN 18:45**

Oh, yeah, I mean George is, George is great. You know, if we can steal, steal more people that'd be even better.

**ND - Lawrence FL 18:57**

Me and George, we used to hang out, like, it was nice because any time like, shit would go south in my house, I'd just go get in my car and drive over to hang out at his house which is 10, like 10 minutes away. And we'd go hang out we get a Poppa Murphy's pizza and sit down and like, watch, and he'd make like tea with his French press or something and then we'd just sit there and like, watch a movie. It was so awesome.

**Matthew MN 19:20**

Yeah, I mean, I think the last time I saw him was at the pool party event. John Minnesota was, set up an event at his house, like, we had like, little, like, Pool Party Thanksgiving event. That was pretty great.

**ND - Lawrence FL 19:37**

Nice. He was telling me about how I was hanging out with the Pool Party guys recently and I saw him [inaudible] finally how it really well.

**Matthew MN 19:45**

Yeah, no most, some regions like, can be really spergy. But I mean, mostly they're pretty cool in my experience, so, I mean, they're decent guys to hang around. Not all of them are cut out to be activists. So if you go in with that expectation, you're going to be disappointed.

**ND - Lawrence FL 20:00**

Yeah, exactly and um, at the beginning I was really disappointed with my guy because he was like, just like, really like, bad with like, bad with like, messaging and like, scheduling, planning time to like, do anything together. I was like, what was the point of like, all that? And then in person we found something we could both do and I was like, you know what? This is a guy that interviewed me and is

like, Pool Party leader, I'm pretty sure I can just trust him with like, things that you can't trust other people with.

**Matthew MN 20:25**

So yeah, most of those guys have been around for a few years.

**ND - Lawrence FL 20:28**

Yeah, and then like, we went to a place where a bunch of people knew me and they basically just kind of doxed me on the spot and I was like, yeah, okay. Whatever, fuck it. You know, whatever, like, once you get like, what's the worst thing he could do? And it's nothing, pretty much, because he's a legit guy. I was like, hey, awesome, but yeah, it was good, we had a really good time together. A he just told me how he's like, yeah, yeah dude, we'll, you know, definitely hang out, hang out again sometime, bring the fiance. But if he brings a fiance it means I need a girlfriend.

**Matthew MN 21:04**

Yeah, I mean, at least in our in our Pool Party we have a policy that the only women we let hang around like, need to be married to a member for a while. Yeah, most of them are very solid.

**ND - Lawrence FL 21:18**

Yeah. I like this one giant girl that I, that goes to the gym. I'm gonna get her to take some videos of me climbing to send to Marshall North Carolina. So he can finally see, oh fuck Tuesday came and went and I didn't [inaudible]. I always forget. And Shannon was there that day too. Dang it. She only came like, like, later on, like, as I was about to leave.

**Matthew MN 21:46**

You know, I still need to go out rock climbing like, I haven't fucking done it. Because I took a second job that's like, seasonal over the holidays just so I can like, make some extra money over the weekends. And I always feel tired after doing it.

**ND - Lawrence FL 22:08**

Yeah, I applied to place maybe like a [inaudible], alright, what do you think, Matthew? Do you think I should take this job like a manufacturing job? It's gonna be like cutting fiberglass and stuff like that. Like, I don't know. It's 15 bucks an hour.

**Matthew MN 22:22**

How much was your other job paying?

**ND - Lawrence FL 22:24**

Like 10 bucks an hour. I don't get any hours at all. I made like \$100 a paycheck.

**Matthew MN 22:29**

Oh yeah, manufacturing you'll get as much hours as you want. I haven't really done like, actual manufacturing work so I can't say but, I don't know, you should, you should take it, dude, the money's worth it, you can as much hours as you want. I forget it's Florida so fucking pay is always shit there.

**ND - Lawrence FL 22:49**

Yeah, it is like, 15 bucks an hour which is good but like, I have a feeling it's gonna be kind of miserable but maybe that's the wrong attitude to have. It's like, it'd be like a factory, just, I mean, maybe it won't be bad, maybe it'd be fine. Like, if I could continue like, working my current job which, honestly, you don't get paid very much at all but it's like, really nice. I would, that would be ideal. I don't want to have to quit.

**Matthew MN 23:16**

I don't know, I'd take, I'd take the job for more money, but that's just me, dude. Like I, I don't know, man, like, I could just couldn't do without the money.

**ND - Lawrence FL 23:28**

True.

**Matthew MN 23:30**

Again, I am like, leveraged to high hell with a bunch of loans.

**ND - Lawrence FL 23:36**

No, I've got student loans coming up in January.

**Matthew MN 23:39**

Yeah, fuckin student loans, auto loans, fucking, all that shit.

**ND - Lawrence FL 23:45**

Yeah. I mean, if I do it, they're only open like, Monday to Friday. But first shift is available. The first shift is like from 6:30 am to like, 4 pm. Which isn't like, ideal, because it's like, I'd probably have to quit my current jobs. I don't think they would let me do like, Monday, Wednesday, Friday at that place. They're gonna want someone to work five days a week, I think at least and then you get the weekend off at least, which is cool. But it's also far away. Like 40 minutes away.

**Matthew MN 24:18**

40, I mean, that's that's like a pretty significant bump though.

**ND - Lawrence FL 24:26**

Yeah, I already travel like 35 minutes to get to my current place, for like 10 bucks an hour. But...

**Matthew MN 24:33**

Yeah, you might as well do it, like. Yeah, it's like, if you drive 30, like, 40 minutes is really not that much of a difference especially for an increase of that much.

**ND - Lawrence FL 24:44**

Yeah, I'm gonna see if I can just do three days a week there. That'd be ideal. If I could keep my current schedule the way things are except just fill all the days I don't do anything with work. That would be ideal.

**Matthew MN 24:56**

Ever tried looking for any office jobs or remote gigs?

**ND - Lawrence FL 24:59**

I mean, the only remote jobs I was getting is like, call center type shit like, customer like, care and whatever else. I was like, dude like, I don't want to be on the phone and get abused all day.

**Matthew MN 25:11**

Yeah dude don't, never do call center shit. Yeah, it's fucked, you could probably look for office jobs, man, I mean, you do technically have a bachelor's, so...

**ND - Lawrence FL 25:22**

I was looking like, I don't know where to look for like, these office jobs because any time I try and go to do one it's like, I have no filing qualifications, right or databases or anything like that and I can never like, I can't do any of that, I don't really know how to get started.

**Matthew MN 25:37**

You just, you just keep going for smaller businesses that literally like, have no choice but to hire you because they don't pay as much as [inaudible] but they also don't expect as much.

**ND - Lawrence FL 25:52**

True. True. I mean, at least my current job I'm like, able to say, yes, I have sales experience, because like, you know, you promote like, and upsell stuff and try and sell people stuff, and administrative because you can book like, you know, appointments and things like that so...

**Matthew MN 26:15**

I'm just glad I chose the line of work that I did, because it's pretty easy to get into and I, I don't deserve the money I'm getting paid.

**ND - Lawrence FL 26:24**

Nice.

**Matthew MN 26:29**

So yeah, anyone looking for jobs like, seriously, software engineering, fuckin do it.

**ND - Lawrence FL 26:36**

Oh, speaking of which, I should check out Morgan and Morgan, see if they do have any openings. Like just the entry level anything.

**Matthew MN 26:45**

I mean, even something as dumb as like, data entry will probably pay more than whatever you're doing. And even if it pays on the same, you at least get to work in a fuckin' office building and you might be able to get a better job eventually.

**ND - Lawrence FL 27:01**

Oh my god, fuck off. Why is this thing being so retarded? There we go, Morgan. I mean, I've never done it before so they might not be like, no, go away, retard. Forthepeople.com, okay. \$10 billion recovered for clients. Wow there's the guy, there's Morgan and then his wife is also Morgan. Okay that's, that's fine. Free case evaluation. Orlando? Oh they're centered in Orlando. Okay, Morgan and Morgan careers. Registered nurse, that's not what I was looking for. There you go. I'm sure they make a ton of money in Florida for injury law because people here get in car crashes all the time, they're absolutely retarded.

Well yeah, Florida's got a lot of niggers, niggers are very bad drivers, like I don't know where Asians earn their reputations for being bad at driving, because niggers are 10 times worse.

Yep.

**Matthew MN 28:36**

Like, every time I drive like, to like, a predominantly black part of town like, you just fear for your life.

**ND - Lawrence FL 28:45**

Yup. "You fear for your life." Oh, hey cool. Yeah, they're over here too, awesome. Definitions? I don't care about any of that right now, just give me give me anything. I'll just try it [inaudible] click [inaudible]. Oh, that's right here okay, I was already on the page, whoops. Retard moment.
