There is approximately 954 OPR violations that are classified as operational and personal violations. We would have to review and redact 954 OPR report to determine which ones are related to email use violations, work-place speech related discipline, and threats or intimation violates. Afterwards, we would have to redact the responsive OPR. Additionally, we would have to work in conjunction with Employee discipline to provide the discipline imposed for all of the OPR cases, arbitration cases, merit board cases, and disciplinary actions. This would lead to the review of 4 years of records. One OPR report alone takes approximal an entire day to redact.

1. CCDOC Federal Funding & Oversight Compliance

I request records of all federal funding and grants awarded to CCDOC from 2019 to present, including:

• Federal grants tied to employment policies, disciplinary procedures, or workplace conditions.

• Any CCDOC agreements with the DOJ, EEOC, or federal oversight agencies regarding employment practices.

In my possession, is all the federal funding awarded to CDDOC from 2020 to the present. The resulted yielded



over 330 pages of records, which would need to be redacted and review. This alone is unduly burdensome as it would take approximately half a day to redact. I've already requested that you narrow this request regarding R069786. An additional search would have to be done for the year 2019.

Additionally, you stated that we just need to complete a simply keyword search. This is incorrect. We have to work in conjunction with several department. For instant, in order to complete a text message search, each of the employees, who's record you seek, would need to come to IT to have their phone legally preserve. Therefore, for the following request:

I request all emails, text messages, memoranda, or reports exchanged between CCDOC officials and the following external entities regarding my case from January 19, 2024 – Present:

Thousands of employees would need to come to IT to have their phone preserve. This process can take between 5 min and 1 hour, depending on the amount of data to review. This alone makes the request unduly burdensome.

Please respond with a narrowed response, such as by (NARROWING TIME PERIOD, DEPARTMENT SCOPE, ETC.), or provide a time you are available to conference call with our office in order to discuss your request.

I acknowledge receipt of your response regarding my FOIA request. I am willing to cooperate in good faith; however, I cannot agree to narrow the scope of my request without a legally valid and detailed justification for why compliance would be unduly burdensome.

Under 5 ILCS 140/3(g), a public body must provide a specific factual basis demonstrating how a request is unduly burdensome, including:1. The estimated number of records that must be reviewed.2. The time and resources required to fulfill the request.3. A detailed explanation of why the requested records cannot be searched and retrieved using reasonable means, such as keyword-based electronic searches.

Your response does not provide any of this information. Instead, it simply states that the request is "overly broad" without justification. This does not satisfy FOIA's legal requirements.

Request for Clarification & Compliance

Before considering any modifications to my request, I ask that your office specifically answer the following questions:1. What portion of my request is burdensome, and why?2. What is the estimated number of responsive records, and why is retrieving them difficult?3. Has your office attempted an electronic keyword search for my request? If so, what were the results? If not, why not?4. What specific narrowing does your office propose, and how does it ensure that the responsive records remain comprehensive and not selectively filtered? Without detailed responses to these questions, I cannot reasonably consider any modifications to my request. Furthermore, as per Illinois Attorney General opinions and FOIA case law, agencies cannot deny requests based on speculative burden alone.

Legal Obligation to Process Request

If your office does not provide a factual basis supporting its claim that this request is unduly burdensome, I expect compliance with my full request within the statutory deadline outlined under 5 ILCS 140/3(d). Failure to do so may result in an appeal to the Illinois Attorney General's Public Access Counselor (PAC) and potential legal action to compel disclosure.
