TAPED Q AND A OF DAQUAN BRADLEY BY SGTS MATTSON AND KEEFE ON 5/21/2004, AT JDC, TYPED BY KP,  
CCN 04-117071

Q: Would you tell me your full name please?

A: DAQUAN OSSIE BRADLEY.

Q: Spell your first name?

A: D-A-Q-U-A-N.

Q: Spell your middle name?

A: O-S-S-I-E

Q: State your last name?

A: BRADLEY, B-R-A-D-L-E-Y.

Q: What's your date of birth?

A: [REDACTED] 1990

Q: Where do you live right now DAQUAN?

A: [REDACTED]

Q: What's your phone number there?

A: [REDACTED]

Q: Ok today it is May 21st, 2004 approx. 9 am and we are at JDC, we're here on a different matter. I'm going to read you your rights at this time. And I want you. I'll have you explain them back to me so that you know what they mean. The Constitution requires that I inform you that you have the right to remain silent. Do you understand that?

A: Means I can be quiet if I don't want to talk.

Q: Correct. Anything you say can and will be used against you in court, do you understand that?

A: Meaning whatever I say would and could be used against me in court.

Q: Yes for example you told a lie, ok, that could be used against you or if you were implicated in a crime, ok, you understand that?

A: Hmhm. Yes.

Q: You have the right to talk to a lawyer now, have a lawyer present now or at any time during questioning, do you understand that?

A: Yes but I don't want one.

Q: Ok if you can't afford a lawyer one will be appointed for you without cost, do you understand that?

A: Uh-huh, meaning I can get one without paying.

Q: Right. Do you understand each of the rights that I read to you?

A: Yes.

Q: And you're willing to speak with us at this time?

A: Yes.

Q: Ok um, prior to taking your statement we showed you a 6 person photo spread is that correct?

A: Yes.

Q: Did you identify anybody that you recognized from that photo spread?

A: MARVIN number two.

Q: Do you know his last name?

A: No I don't.

Q: What do you, do you know anything else as far as his name, does he have a nickname that you call him?

A: LITTLE M, we call him MARV, we call him MARMAR.

Q: Ok LITTLE M, MAR, or MARMAR ok and his real name as far as you know is MARVIN.

A: Uh-huh.

Q: Ok did you see MARVIN on Sunday May 16th in the morning?

A: I saw him at, it was 8 o'clock or 9 o'clock. When he came and he woke me up.

Q: When you say he woke you up where were you?

A: I was at one of my friend's house MUFFIES.

Q: MUFFIES house?

A: On 29th and Logan.

Q: Ok, do you know MUFFIES real name?

A: JOSLYN.

Q: JOSLYN do you know her last name?

A: No I don't.

Q: Ok, all right, you were sleeping over at MUFFIES?

A: Yes I was.

Q: Ok and MARVIN showed up, was he with anybody else?

A: No he wasn't.

Q: What did he wake you up for?

A: He asked me do I want to hit a lick with him.

Q: What does hit a lick mean?

A: Go rob somebody and come up some on some money.

Q: Ok at that time did you see MARVIN driving anything?

A: It was a Ford grey or red pick up truck.

Q: Ok do you know whose vehicle that would be?

A: No I don't.

Q: Ok at that time, did you see MARVIN with any weapons at all?

A: No I didn't.

Q: Ok, um did MARVIN tell you where he was going to hit a lick?

A: No he didn't, he just told me he was going to hit a lick and come up.

Q: Did you go with him?

A: No I didn't.

Q: Ok did he leave, leave MUFFIES house?

A: Yes he did.

Q: And you stayed at MUFFIES house?

A: Yes I did.

Q: Ok, um do you know anything about what robberies he would have done on Sunday?

A: Well he, I guess he robbed the flower shop.

Q: Ok why do you say that?

A: Cuz what he was telling us yesterday.

Q: Ok

A: When we was in the...

Q: Ok first of all you first saw him when he invited you along on Sunday the 16th to hit a lick correct?

A: Yes he did.

Q: Ok and how long have you known MARVIN?

A: Two, three weeks.

Q: Ok and then the next time you saw him was yesterday?

A: The last time I saw him was yesterday.

Q: Ok and that was down at Juvenile Detention Center here?

A: Yes it was.

Q: What did MARVIN tell you when you saw him at JDC?

A: That he hit a sweet lick and he came up.

Q: Did he tell you who could have done this robbery with him?

A: Him, his cousins SIX and POOPEY.

Q: Do you know who his cousins are?

A: No I just know LUCKY.

Q: Did he tell you if anybody got shot during this robbery?

A: Yes he did he tell me this is exactly what he said, "I did this" blah, blah, blah. (witness making shooting motions with hand).

Q: Hold on did he say he is the trigger man or somebody else was?

A: He said, this is what he did. This is what I did.

Q: This is what MARVIN..

A: Blah, blah, blah.

Q: This is what MARVIN is telling you?

A: Yes.

Q: Ok all right, did he say why he had to shoot somebody?

A: No he didn't tell me why.

Q: Did he specify when you were talking to him on Thursday the 20th at the Juvenile center did he specify which robbery he was talking about?

A: Whatcha mean specify?

Q: Did he tell you that it was the flower shop or did he just say he did a robbery where he shot somebody?

A: He hit a lick on 33rd and Lyndale.

Q: That's what MARVIN told you?

A: Yeah.

Q: Ok and that's the same MARVIN that you identified in the photo spread is that correct?

A: Number two.

Q: Ok you signed that photo is that correct?

A: Yes it is.

Q: All right. KEEFE: DAQUAN when you say that MARVIN told you that he hit a sweet lick and

came up what does that mean to you?

A: It means that he just, robbed somebody and came up. Like the hundreds and hundreds. He got money now, he came up. Hes not, like how he used to be, he came up.

Q: Did he tell you specifically he got money from the flower shop?

A: Naw he just told me he came up, I shoulda came. He came up.

Q: But he never told you specifically that he got any money from the flower shop? Yes or no?

A: No. he just told me he came up.

Q: Ok

A: Off a sweet lick.

Q: Ok and when he simulated um, by gesturing pow, pow, what did that mean to you?

A: That he shot at somebody.

Q: Did he tell you who he shot?

A: Nope. He just told me he shot at somebody.

Q: MATTSON: Did he say what he did after the robbery?

A: Ran.

Q: Did he say where?

A: He went home, laid down.

Q: KEEFE: Did he say how he got home, did he walk, did he ride, did he take a vehicle?

A: No he didn't tell me all that. But if it was up to me, if they, if they, did go in a car I take it as they left in that car.

Q: KEEFE: Ok when he told you this was there anyone else around in the Juvenile Center?

A: There was 4 of us total. Him, me some other black African American and a guy named POW or PAH.

Q: And what is his race?

A: Uh Asian. Or Hmong, Asian or Hmong.

Q: Ok, did MARVIN ever ask you to provide him with an alibi?

A: Yes he did. He told me if I take up for him he will take up for me.

Q: MATTSON: Take up what does that mean to you?

A: Help him in his situation and he help me out in my situation.

Q: But I mean did he ask you to lie and say that he was with you at the time of this robbery?

A: Yes he did, yes he did.

Q: Ok and then what was he going to do in exchange for that?

A: He didn't say, see, I would've been caught up.

Q: KEEFE: Did he specifically ask you to provide him an alibi for the incident at the flower shop?

A: He just told me to tell the judge that me and him was out having fun but we wasn't, that he had nothing to do with the flower shop.

Q: Ok

A: He just told me to tell them that he was having fun.

Q: Ok he told you to tell the judge that you and him were out having fun and that he had nothing to do with the flower shop?

A: Nothing.

Q: MATTSON: MARVIN excuse me DAQUAN is everything you told us true to the best of your ability?  
A: It's true.

Q: Ok and you understand that we are taping this so that we can get your words because you had conversation with MARVIN so we are asking you tell us the truth to the best of your ability about what MARVIN asked you to do or, or what he told you about what happened?  
A: Yeah.

Q: Ok, were you involved in this robbery at all?  
A: No, no I wasn't.

Q: Were you aware of this flower shop being robbed prior to MARVIN telling you about it, for example did you see it on the news or see it on the streets?  
A: No I didn't.

Q: KEEFE: Did MARVIN ever tell you prior to Sunday that he and his friend had planned to rob the flower shop?  
A: Yes he did.

Q: Not the flower shop (specifically)  
A: He just told me that they was going to go sweet lick on a sweet place and come up and ya know get money and stuff like that. Have money and come up.

Q: MATTSON: He didn't specify to you necessarily the flower shop but you knew he planned a robbery somewhere?  
A: Yeah.

Q: KEEFE: And did he tell you that he was going to come up big, big money?  
A: Yeah. That's all he told. I was like all right. Talk about the sweet lick. And then I went over to my aunties house, my cousin FAVIAN and ERIC at STEPHANIES house and I was there with ERIC to watch my little cousin LITTLE EDDIE and when they came for school and then my auntie and my cousin ANTHONY pulled up and we took it.

Q: What day was this?  
A: Sunday. And then they pulled up and then we took the laundry out the car and took it in the house and then my mom called over to my cousins house and I was talking to my mom on the phone and she told me to come home and I stayed at my cousins house. And bam.

Q: Bam what?  
A: It was around 3 something.

Q: I thought you said in bed.  
A: No

Q: Did you say...  
A: No I said and bam.

Q: And Bam, ok I just heard you wrong. KEEFE: Are you willing to testify in court to what you just told us today?  
A: Yes I will.

Q: Is this a true and accurate statement given of your own free will and accord?  
A: Yes it is.

Q: Ok end the interview at this time it 0922 hours.
