Q: Would you state your full name please?

A: PEREZ WRENCHER, P-E-R-E-Z M-O-N-R-E-L-L W-R-E-N-C-H-E-R

Q: And what's your date of birth?

A: 1987 [REDACTED]

Q: Ok where do you live right now?

A: On [REDACTED] Clinton Ave S.

Q: Ok what's your phone number there?

A: [REDACTED]

Q: Ok, um, is it true MR WRENCHER we showed you a 6 person photo spread prior to this conversation we are having?

A: Yes.

Q: Ok did you identify the person in photo number 2 as the person you were in JDC here with?

A: Yes.

Q: What do you know that person's name to be?

A: LAMAR, LIL MAR.

Q: LEMAR or MAR?

A: LIL MAR..

Q: Ok. KEEFE: Little MAR?

A: Yeah.

Q: Ok LITTLE MAR. Um do you know him personally or do you just know him from being in JDC together?

A: Through JDC together.

Q: He's not a friend of yours?

A: Na-huh.

Q: Ok, yesterday which would be Thursday the 20th, were you up in like a court holding room with LITTLE MAR?

A: Yeah.

Q: Ok was there also an Asian guy up there named PAH?

A: Yeah.

Q: Was there maybe one or two other people that you don't necessarily know that were up there in the court holding?

A: Yeah.

Q: When you were up in court holding, did you hear LITTLE MAR um, making any statements to anybody about the, did you hear him talking?

A: Yes.

Q: What was he saying?

A: He was talking about the guns, how many guns he be shooting, how many guns he can get, and all that, what he gonna do when he gets out of the block.

Q: Ok what kind of statements did he make, did he tell you he had a lot of guns?

A: Yes.

Q: Ok did he say he shoots a lot of guns?

A: Yes.

Q: Do you remember his exact, his exact words in respect at all to those two things?

A: Um he said, he said I be shooting a lot of guns. He said, I can get any kind of gun I want. I don't know.

Q: Ok um, do you recall if he made any mentions to you about any robberies?

A: No.

Q: Ok now is it correct that while you are in court holdings people come and go at various times?

A: Yes.

Q: Ok and others stay behind?

A: Yes.

Q: So you wouldn't necessarily hear the entire conversation?

A: Yeah.

Q: That he might be saying is that correct?

A: Yeah.

Q: Ok when LITTLE MAR was up there talking what else do you recall him talking about that you remember, that you heard?

A: Uh, hes talking about all the girls he be with and stuff.

Q: Ok all right um, is LITTLE MAR someone that you known from anywhere else?

A: Nu-huh he said I look familiar. I don't really remember him like that.

Q: Ok, hes not somebody known to you?

A: Yeah.

Q: All right, is everything you told me..Keefe: Oh I got something. Mattson: Ok. Keefe: You said that he made reference to doing something or some things after he got out on the block, specifically what did he say?

A: He say, he gonna get, get his money and he gonna go get, get his dope and get back on the block and stuff.

Q: Keefe: He was going to what now?

A: Get his dope and hes going to go sell it on the block and get his money.

Q: Keefe: Get his money?

A: Yeah. Yeah he say hes going to get his money.

Q: Keefe: Ok does someone owe him money?

A: Nu-huh he just sell like, like getting his dope and selling it.

Q: Mattson: Getting, getting rich by selling dope is that what you mean by getting his money?

A: Yeah.

Q: Ok is everything you told us true to the best of your ability?

A: Yes.

Q: Ok we'll end this statement at this time. It is 1007 hours.
