
SUPPLEMENT BY SGTS KEEFE AND MATTSON - 5/24/04

On 5/17/04 at approximately 0900 hours SGT KEEFE sent a subpoena to Kare 11 News requesting their news footage from their 5 and 10 reports on 5/16/04 regarding the murder at Jerry's Flower Shop. Investigators were trying to identify two women who were talking to CYNTHIA MCDERMID shortly after her brother was killed. SGT MATTSON recovered the news footage and upon viewing it investigators had still photos printed of these two females. Investigators then called northside CRT officers GEERE and CREIGHTON to the Homicide Office to see if they could identify these two women. GEERE and CREIGHTON immediately identified these two as CHARMEL PATRICE DOCKERY, DOB [REDACTED] 55 and her daughter LAMEKIA DOCKERY, DOB [REDACTED] 82. Investigators contacted CHARMEL DOCKERY at around 1900 hours at her home in north Minneapolis. DOCKERY told investigators that while standing near the crime scene she overheard some men state that the flower shop was actually supposed to have been robbed a few days earlier. However, she did not know their names or who was supposed to rob the place.

On 5/18/04 SGT MATTSON requested a truck from the property warehouse to meet myself and the business owner at the flower shop to retrieve some card racks which the suspect may have handled cards on. SGT MATTSON instructed the property technician on which card racks to take and there were three separate racks. The first rack was a large free standing card rack to the right of the main entrance, the second rack was a small counter top card rack from the checkout counter and the third rack was a stand alone revolving rack near the checkout counter. These racks were wrapped in clean paper prior to taking them outside so that none of the cards would blow away. These card racks were then brought out to the property warehouse shipping truck and they were brought to the property warehouse so that cards could be fingerprinted.

At approximately 1230 hours on 5/18/04 SGT KEEFE received an anonymous tip that the shooter in the flower shop murder was a 16 year old black male known as "LITTLE MARVIN". Additionally SGT KEEFE was told that LITTLE MARVIN's sister lived at 2211 Bryant Avenue North and LITTLE MARVIN's mother's first name is SHARON. Routine checks revealed that MARVINA SHIPP lived at 2211 Bryant Avenue North, Minneapolis, MN. Furthermore her mother was listed as SHARON SHIPP and SHARON had a son by the name of MARVIN HAYNES.

Also on 5/18/04 SGT MATTSON was contacted by officer DENNIS MAKI of St. Louis Park PD. He had been contacted by a person known to him who stated that they may in fact be a witness in this case. Officer MAKI introduced myself to this person on 5/19/04 who wishes to remain anonymous for their safety. This witness is thus identified as Witness B and is known to officers. Witness B stated that they would probably recognize the suspect. No photo was shown at this time as officers were still working on developing a suspect. Witness B summarized that they had been at a church in north Minneapolis and had left church to get something to eat and was walking near the flower shop when Witness B heard a shot and saw a person run out of the flower shop. Witness B described this person to myself as a slender black male and a natural haircut possibly faded on the sides and some sort of a light blue (possibly zip up) sweatshirt.

At approximately 1615 hours investigators went to 3343 6th Street North and talked to DAVID NEIL. Investigators noted that DAVID NEIL has a large gap between his teeth. We also saw his brother RAPEAL JONES. RAPEAL is very heavysset and did not match the description given by CYNTHIA MCDERMID.
