Q: Could you give me your full name and birthday please?

A: ANTHONY MICHAEL TODD.

Q: ANTHONY MICHAEL TODD and what is your birthdate ANTHONY?

Q: Ok 2/25/1990. And what's your current address and telephone number?

A: [REDACTED]

Q: [REDACTED] is that north or south?

A: North.

Q: In Mpls MN?

A: Yes.

Q: And what is your mother's name?

A: LISA CHILDREY

Q: LISA CHILDREY?

A: Yes.

Q: Ok and a few moments ago did your mother give SGT MATTSON and I authorization to talk to you?

A: Yeah.

Q: Calling your attention to the morning of May 16th 2004, do you recall going over to MUFFY's house?
