Q: Could you give me your full name please?

A: JEREMY ALEXANDER DAVENPORT.

Q: JEREMY what is your birthdate?

Q: JEREMY what is your address?

A: Maple Grove.

Q: What's your home telephone number?

Q: Ok on the morning of May 16th, 2004 did you go over to MUFFY's house?

A: Yes.

Q: And where does MUFFY live?

Q: On Logan what?

A: 30th.

Q: At around 30th and Logan in what city?
