Q: Would you state your full name please?

A: JOSILINN SHANAE MORGAN.

Q: Ok could you spell your first name?

A: J-O-S-I-L-I-N-N

Q: And spell your middle name.

A: S-H-A-N-A-E and a space between the ANN and MORGAN.

Q: And what's your date of birth?

A: [REDACTED]

Q: Ok and what's the address that you're staying with, is that your dad right now?

A: Uh I think [REDACTED]

Q: And that's in what city?

A: Memphis Tennessee.

Q: Ok and what's your phone number down there?

A: Um [REDACTED]

Q: Ok and what nickname do you go by?

A: MUFFY.

Q: MUFFY ok and you used to live up at 2938 Logan N upstairs?

A: Yeah.

Q: Ok and do you remember my partner and I speaking to you about, lets see it would been roughly May 21st I think it was, anyway do you remember us talking with you about, inquiring about a guy by the name of POOPEE?

A: Uh-huh.

Q: Ok and or DAQUAN. Ok and concerning an incident that we're investigating that happened on Sunday May 16th 2004 we had come over and talked to you, do you remember who would have stayed over night there from Saturday night May 15th to Sunday May 16th 2004?

A: Uh nope, I don't remember like, all that.

Q: Ok did DAQUAN BRADLEY was he there on Sunday the 16th?

A: Yeah he was there mostly every day.

Q: Ok had DAQUAN stayed overnight or did he come there in the morning, if you recall?

A: I don't remember.

Q: Ok but he was there on Sunday morning the 16th?

A: Yeah.

Q: Ok and who else had come over?

A: Uhh, POOPEE had came over.

Q: POOPEE ok. Anybody else.

A: I don't, I don't remember all that.

Q: Ok did MARVIN HANES come over?

A: I'm not too sure, he probably did.

Q: Ok just a moment ago when I was talking to you didn't you tell me that you thought MARVIN HANES had come over?

A: This Sunday?

Q: Pardon?

A: Tomorrow is Sunday?

Q: On Sunday May 16th yeah?

A: Yeah.

Q: Do you recall if anybody else had come over besides DAQUAN, MARVIN and or POOPEE?

A: Umm, our neighbors from across the street, that's it.

Q: Ok um, was this in the morning?

A: Yeah like between 11:30, 12.

Q: Ok are you for sure on the time or?

A: Basically.

Q: Ok were they there for a long time?

A: No not MARVIN.

Q: How long was MARVIN there ya think?

A: Like 15 minutes then he went home. He changed his clothes.

Q: How do you know he went home or do you just know that he left?

A: No he told me he's going home.

Q: Ok did you go to his home with him to see where he went?

A: Uh-uh (negative).

Q: Ok who did he leave with?

A: By himself.

Q: Ok did the other people stay or did they leave?

A: Um DAQUAN stayed, POOPY left the opposite way of MARVIN. They left like 10 minutes after MARVIN did.

Q: Ok do you recall if anybody else was there?

A: Uh-uh (negative)

Q: Ok did you hear DAQUAN, MARVIN and POOPEE talking?

A: No.

Q: Were they talking amongst themselves?

A: Huh?

Q: Were they talking?

A: Yes.

Q: Were they inside or outside?

A: Out.

Q: Ok were you with them?

A: No.

Q: Ok you just happened to know they were there and or dealing amongst themselves but you don't know what was said is that correct?

A: Yes.
